## INFO FOR EXECUTOR OF WILL By Virginia Erhardt

STEP 1. Immediate phone calls: 1) call my doctor's office. Tell staff or answering service that I died. 2) unless the sheriff's office already knows I died, call: 360.378.4151. They must notify
the coroner before the body is picked up by the funeral home or crematorium. If I die at home, you'll be notified. 3) please call the crematorium I've chosen and request pick up of my body at
a time it's convenient for you to be at my house. You won't have to go to the crematory at any
point. Contact info: If I die elsewhere, the EMT's and
Sherriff's office will be involved and they will get the info from a card in my wallet and notify you of my death. They'll make the arrangements for transport of my body to the funeral
home/crematorium.
The funeral home has the legally required Authorization for Cremation and Disposition form,
which I signed and sent them. All arrangements have been made other than payment, which
should be \$1,200-\$1,500 (their April, 2016 estimate was \$1,185).
They will send a bill. They will want to be paid within 2 weeks of picking up my body, so it's
important to get the ball rolling to get the Letters Testementary/Personal Representative Form from San Juan County Court to take care of things at the bank so you can sign checks for my
estate. The funeral home has been instructed to mail the cremains to my Executor. Make sure
they have your address for that, if you're not the first person on my list of potential executors. They have my primary executor's contact information, but there wasn't a place on their form
for alternate executors.
There are instructions in my will as to the distribution of my cremains. My next of kin are aware
of the kind of service I want. I have no desire for publication of an obituary.
The funeral home will send you 5 certified copies of the death certificate, which should be more
than enough for any entities that will require one as my estate is being probated. They do that
quickly.
STEP 2: <b>ASAP</b> , contact the probate attorney. You'll need the original of my will, which is located
, with other files e.g. the one regarding cremation.  The Probate Attorney I've selected and his contact info is
With him, everything can be handled without meeting or going to court yourself. I've informed

STEP 3. Banking/Bill Paying: According to Candace Bodenhamer, the current manager of the Orcas branch of Islanders Bank (direct line 1235), the bank may magically find out that I died and freeze my checking account, freezing autopayments I've set up. If the account is frozen, the bank won't honor any checks written on or after the date of my death.

him that I want him to handle probate of will. Early in the process, until he gets the **Letters Testementary/Personal Representative Form** to you, time is of the essence, so faxing back and

forth is very helpful. You can send and receive faxed at Office Cupboard.

So, immediately beginning the process with the attorney is vital. He'll go to court as soon as you notify him of my death and file to open probate of my estate and to get you appointed my Personal Representative. He'll send you the Letters Testementary for San Juan County Court that you'll need, particularly for deal with financial matters. Once you have the **Death Certificate** and the **Letters Testementary/Personal Representative Form** for the attorney, you'll sign before a notary as Petitioner. You can do this at Islanders Bank. You can do it wherever you prefer, but you will have to go to Islanders anyway with the paperwork mentioned in bold print in this paragraph. The paperwork will enable you to close my current checking account and open one named: "(Executor's name), as Personal Representative of the **Estate of Virginia Erhardt, Deceased**". They'll transfer the money from my old account into this new account and you will have the sole power to sign checks on that account.

While you'll be closing various accounts, some entities will continue to require payment, e.g. water, sewer, mortgage, land lease and OPALCO until it's time to either shut them off or transfer them into a renter or buyer's name, since the house is a legacy gift to OPAL.

It makes sense to me <u>not</u> to set up auto payments that would be in force for such a brief period of time. You might as well just check my PO Box \_\_\_\_\_ often for bills ad pay by due date, although all that's up to you.

Below, you will find numbers to call to tell people I dies and to stop sending bills, or expecting payments, e.g. my health insurance, etc. Some, e.g. credit cards, may give you final payment due amount as of the day you inform them and you'll send them a check, once you've got the Estate checking account open. Or, they'll send a final bill in the mail. Paying most of my hills will be required of you for a very brief time.

You'll also find below a list of bills some of which are identical each time, set up to be paid automatically by my bank. Others I pay when the bill comes in the mail. This list is to give you an idea of how extensive your temporary financial duties will be.

My IRA Annuity distribution is automatically deposited annually in January. No further distributions will be deposited after my death. Social Security auto deposits are made monthly on the fourth Wednesday, but the funeral home is required to inform Social Security of my death and those payments will stop. That's it for income. I've already arranged with my publisher for book royalties to be sent to my granddaughter.

Questions about my IRA can be addressed to	my financial advisor. Name and contact
info:	With the special powers of your paperwork, you

can have funds sent to you from my IRA Money Market account for expenses, if you need more than what's in checking. My financial advisor has the info about the percentage to go to each of my heirs. He'll need an official copy of the death certificate to release any remaining funds in the IRA.

Please give my heirs (my son, and each of my grandchildren, whose contact info is in the addendum) contact info for my financial advisor. My heirs have to call or email him to provide him with their current contact information. He'll set up accounts for each heir and disperse funds to them from those new accounts.

Feel free to insist that my son and grandchildren be organize about coming to get stuff they want from my house so it's convenient for you. Also, let them know that anything not removed within 30 days of their notification will be sold at an estate sale that you'll hire someone to run.

When my family has taken all of my possessions they want (see my will for specifics), and you have taken anything you want, an estate sale has been held, run by your choice of person(s), with costs paid by the estate and profits kept by you, the rest of my stuff will have to be disposed of. You might check with Ian and Erica Harlow (6950) to see if they still do removal and disposition, or anyone you prefer. Then please hire someone to clean the house. For my previous move-out cleanings, I've hired \_\_\_\_\_

Judging by what attorney and court fees were in 2013, I'd anticipate the total when I die to be around \$2,000.
